SUBJECT: Citywide Cat Program Final Environmental Impact Report and
Consideration of Project Approval by the City of Los Angeles

The City of Los Angeles (City) has prepared the Final Environmental Impact Report (EIR) for the proposed Citywide Cat Program (proposed Project). The Final EIR includes the revised proposed Project description (Chapter 1), comments received on the Draft EIR during the public review period (Chapter 2), and technical modifications and revisions to the Draft EIR (Chapter 3), along with the revised Appendices. Chapter 2 includes comments received on the Draft EIR during the public review period from August 29, 2019 to October 28, 2019 via mail, email, and at the public meeting held on October 7, 2019, along with the City's responses to these comments. Please refer to the Table of Contents in the Final EIR for the organization of the responses to comments. Certification of the Final EIR and approval of the proposed Project requires review from the City's Board of Animal Services Commissioners and action by City Council.
