☐ If the applicable cat receiving permission to remain intact unintentionally breeds during the permit period, I shall be responsible for acquiring a Breeder's Permit and shall also be responsible for any applicable penalties. Initials
☐ The applicable cat shall be strictly confined while in heat or season in a building or other adequate enclosure designed to keep him or her on the premises of the owner, as required by the City's Municipal Code. Initials
☐ I understand that if the applicable cat no longer meets the exemption listed above, it must be spayed or neutered within 60 days of the day the cat no longer qualifies. Initials
☐ It is my sole responsibility to promptly update any changes in the information provided on this application, including any change of addresses or telephone contact information, and fully understand that an approved intact cat permission is not transferable. Initials
