This Intact Dog License Application shall not be accepted unless accompanied by the fee, microchip number for the applicable intact dog, valid rabies certificate and, as applicable, either proof of exemption to the spay/neuter requirements of Section 53.15.2 of the Los Angeles Municipal Code (LAMC) or a valid Breeder's Permit or Breeder's Permit Application. Fees are non-refundable. This license cannot be transferred.

The dog is a breed approved by and the dog is registered with a registry or association recognized by the Department through its Commission, whose program and practices are consistent with the humane treatment of animals, and the dog is actively used to show or compete and has competed in at least one legitimate show or sporting competition hosted by, or under the approval of the recognized registry or association within the last two years, or is being trained or groomed to show or compete and is too young to have yet competed. The dog is appropriately trained or is in the process of being trained and is actively used by law enforcement agencies or the military for law enforcement, military or rescue activities. (Attach original letter or certificate from law enforcement agency with original signature.)

**I hereby acknowledge that I am familiar with Los Angeles Municipal Code Section 53.15.2 and I declare that (check each and initial):**
